In the event of the sale of your vehicle or watercraft, please respect the following procedure:

1. The administrative fee of \$ 100 plus applicable taxes must be paid before making the transfer;
2. The contract must be transferred within 30 days of the sale date of your vehicle or watercraft;
3. Any remaining manufacturer's warranty, still in force, must also be transferred to the new purchaser;
4. You must submitted with this form a copy of the first page of the original contract, proof of discharge for the vehicle or watercraft and payment of the administrative fee of \$ 100 plus applicable taxes in the name of the KM Plus Warranty Inc.;
5. The original contract and all evidence of maintenance of the vehicle or watercraft must be given to the new owner. These evidence of maintenance must be kept as well as any other document relating to the vehicle or the watercraft by the new owner in accordance with the supplementary mechanical warranty contract. KM + may, at its discretion, require evidence of maintenance that may affect any claim ;
6. The refund option **is not transferable** as stipulated in the warranty contract;
7. Please read carefully section 4.1 of the additional warranty contract relevant to the transfer to know all the contract provisions.

**Important Note:** The transfer will not be effective until the original owner signs this form and the new owner receives the transfer letter from KM + confirming such transfer. Please contact KM + if you have not received the letter within 45 days of the request.
